INTRODUCTION

A Touchstone® file (also known as an SnP file) is an ASCII text file used for documenting the n-port network parameter data of an active device or passive interconnect network. While Touchstone® files have been accepted as a de-facto standard for the transfer of frequency dependent n-port parameters, up until this document no formal specification of the file format or syntax had been produced. This document, based upon information from Agilent Technologies, Inc. (the originator of Touchstone®) is a formal specification of the Touchstone® file format, intended for use with documents and specifications produced by the IBIS Open Forum.

Version 2.0 was created based upon the original Touchstone® definition, with added features in the style of IBIS (I/O Buffer Information Specification) and the ICM (IBIS Interconnect Model) specification. Files written using the original syntax are compatible with the updated specification and are treated as Version 1.0.

GENERAL SYNTAX RULES AND GUIDELINES

The following are the general syntax rules and guidelines for a Touchstone® file.

1. Touchstone® files are case-insensitive.
2. Only ASCII characters, as defined in ANSI Standard X3.4-1986, may be used in a Touchstone® file. The use of characters with codes greater than hexadecimal 07E is not allowed. In addition, ASCII control characters (those numerically less than hexadecimal 20) are not allowed, except for tabs or a line termination sequence (carriage-return or carriage-return/line-feed combination).

Note: The use of tab characters is strongly discouraged.

3. Comments are preceded by an exclamation mark (!). Comments may appear on a separate line, or after the last data value on a line. Comments are terminated by a line termination sequence (i.e., multi-line comments are not allowed).
4. Touchstone filenames have traditionally used a file extension of '.snp', where 'n' is the number of network ports of the device or interconnect being described. For example, a Touchstone file containing the network parameters for a 2-port device would be named 'filename'.s2p, while a Touchstone file containing the data for a 3-port network would be 'filename'.s3p, and so on.

Not all operating systems may recognize filename extensions with variable contents or length as associated with the same type of file. To address this, the extension .s2p often has been applied to Touchstone files describing systems containing other than two ports. For the same reasons, the extension '.ts' is suggested for Touchstone 2.0 files.

To preserve support of existing Touchstone files and ensure maximum compatibility across operating systems, the use of filename extensions other than those recommended here is permitted by this specification.

For Version 2.0 and above, the [Number of Ports] keyword establishes the expected number of ports defined in the file.

5. All angles are measured in degrees.
6. Scientific notation IS allowed (e.g., 1.2345e-12). No minimum or maximum limits are placed on numerical precision on individual data points.
7. Keywords (as used in Version 2.0 files) must be enclosed in square brackets, [], and must start in column 1 of the line. No space or tab is allowed immediately after the opening bracket '[' or immediately before the closing bracket ']'. If used, only one space (' '), dash ('-') or underscore ('_') character separates the parts of a multi-word keyword.
8. Arguments after keywords must be separated from the closing bracket of the keyword by at least one whitespace character. Except where otherwise noted, this whitespace separation may not include carriage return or line feed characters.

FILE FORMAT DESCRIPTION

Introduction

Touchstone® data files consist of an 'option line' followed by network parameters taken at specific frequencies. The option line specifies (among other things) the kind of n-port parameters the file contains (S-parameter, Z-parameter, etc.) and the format of the data values (magnitude-phase, real-imaginary, etc.). Data is arranged into groups of n-port parameters preceded by the frequency at which the data was taken or derived. For each frequency, data for a 1-port or 2-port network is contained on a single data line while data for 3-port and above networks is arranged in a matrix row-wise order. The Touchstone® format supports matrices of unlimited size.

Version 2.0 adds to the above several additional keywords: [Version], [Number of Ports], [Two-Port Data Order], [Reference], [Number of Frequencies], [Network Data], [Number of Noise Frequencies], [Noise Data], [Matrix Format], [Mixed-Mode Order], [Begin Information], [End Information], and [End]. The [Number of Ports] keyword and data specify the number of single-ended ports represented by data in the file. The [Reference] keyword and data provide the reference impedances for each port, using the same order as the port data itself. [Matrix Format] specifies the arrangement of network data. [Number of Frequencies] and [Number of Noise Frequencies] specify the number of frequency points and noise frequency points, respectively, contained in the file. [Network Data] and [Noise Data] identify the network and noise parameter data blocks, respectively. [Mixed-Mode Order] identifies how differential and common-mode network data is represented in the file and relates to the single-ended port definitions. [Begin Information] and [End Information] surround a data block identifying application-specific keywords and data. [Two-Port Data Order] explicitly identifies the insertion loss data ordering for 2-port networks. [End] denotes the end of the file contents.

Network data may represent either conventional n-port parameters (corresponding to what is referred to as single-ended port configuration) or mixed-mode parameters associated with differential port configurations. The mixed-mode parameters can be the generalized mixed-mode parameters if not all single-ended ports are combined into differential ports. A differential port is formed from two single-ended ports having the same "reference" terminal (also referred to as the "-" terminal).

In addition to the above option lines, keywords and data lines, files that describe 2-port devices may also contain noise parameter data. Comment lines may be interspersed in the file as necessary.

These keywords and data formats are described in detail in the following sub-sections.

Comment Lines

Touchstone® data files may include comments. Comments are preceded by an exclamation mark (!). Comments may appear on a separate line, or after the last data value on a line. Comments are terminated by a line termination sequence (i.e., multi-line comments are not allowed).

[Version]

Rules for Version 1.0 files:

The [Version] line is not permitted for Version 1.0 files.

Rules for Version 2.0 files:

[Version] is required for files using any Version 2.0 syntax.

Each Touchstone® Version 2.0 data file must contain one and only one [Version] keyword and entry. This must precede all other non-comment lines. Both the opening and closing brackets are required. The [Version] line contains one string argument. The argument must be preceded by whitespace.

The [Version] line provides information on the Version of the specification under which the file contents should be interpreted.

The only valid argument is '2.0'.

Option Line

Each Touchstone® data file must contain an option line (additional option lines after the first one will be ignored). The option line is formatted as follows:

```
# <frequency unit> <parameter> <format> R <n>
```

where

marks the beginning of the option line.

frequency unit specifies the unit of frequency. Legal values are GHz, MHz, kHz, Hz. The default value is GHz.

parameter specifies what kind of network parameter data is contained in the file. Legal values are:

S for Scattering parameters,
Y for Admittance parameters,
Z for Impedance parameters,
H for Hybrid-h parameters,
G for Hybrid-g parameters.

The default value is S.

format specifies the format of the network parameter data pairs. Legal values are:
DB for dB-angle ($\text{dB} = 20 \cdot \log_{10}(\text{magnitude})$),
MA for magnitude-angle,
RI for real-imaginary.

Angles are given in degrees. Note that this format does not apply to noise parameters (refer to the 'Adding Noise Parameters' section at the end of this document). The default value is MA.

R n specifies the reference resistance in ohms, where *n* is a real, positive number of ohms. The default reference resistance is 50 ohms. Note that this is overridden by the [Reference] line, described below, for files of [Version] 2.0 and above.

Option line parameters are separated by one or more whitespace; the option line itself is terminated with a newline character (either CR or CR/LF). If a parameter is missing, the default value is assumed. With the exception of the opening # (hash mark) symbol and the value following 'R', option line parameters can appear in any order.

In summary, the option line should read:

For 1-port files: # [Hz|kHz|MHz|GHz] [S|Y|Z] [MA|DB|RI] [R n]

For 2-port files: # [Hz|kHz|MHz|GHz] [S|Y|Z|G|H] [MA|DB|RI] [R n]

For n-port files: # [Hz|kHz|MHz|GHz] [S|Y|Z] [MA|DB|RI] [R n]

For mixed-mode files: # [Hz|kHz|MHz|GHz] [S|Y|Z] [MA|DB|RI] [R n]

where the square brackets ([]) indicate optional information; ...|...|... means to select one of the choices; and *n* is replaced by a positive integer or floating-point number. Though specific cases are used for the units above and throughout this document (e.g., 'kHz'), Touchstone® files are case-insensitive.

Note that the reference impedance specified in the option line applies to all ports described in the data lines, if [Reference] is not present.

Rules for Version 1.0 Files:

For Version 1.0 files, the option line must immediately precede any data lines and must be the first non-comment line in the file.

The reference resistance defines the system reference for the S-parameter data and the normalization used on G-, H-, Y- and Z-parameter data.

Rules for Version 2.0 Files:

For Version 2.0 files, the option line must follow the [Version] keyword and precede any network data.

For Version 2.0 files, the reference resistance defines the system reference for the S-parameter data if the [Reference] keyword is not present. Normalization does not apply to Version 2.0 files. Therefore, the reference resistance and [Reference] keyword have no impact on G-, H-, Y- or Z-parameter data in Version 2.0 files.

Mixed-mode network parameters may be described in the file if the [Mixed-Mode Order] keyword is present. Mixed-mode parameters are only supported for S-, Y- and Z-parameter data.

Per the defaults above, an empty option line (a single hash mark without any non-comment characters following it) in a Version 1.0 file would indicate that the file uses GHz units for frequency, single-ended S-parameters for the network data, magnitude-angle (MA) for the network data format and 50 ohms as the reference or normalization resistance. In a Version 2.0 file, the same defaults would apply, except that no normalization would be assumed and any [Reference] entry would supersede the 50 ohm reference resistance assumption.

Option Line Examples

Note these examples assume Version 1.0 syntax:

Minimum required option line example, using all default values:

```
#
```

Frequency in GHz, S-parameters in real-imaginary format, referenced to 100 ohms:

```
# GHz S RI R 100
```

Frequency in kHz, Y-parameters in real-imaginary format, normalized to 100 ohms:

```
# kHz Y RI R 100
```

Frequency in Hz, Z-parameters in magnitude-angle format, normalized to 10 ohms:

```
# Hz Z MA R 10
```

Frequency in kHz, H-parameters in real-imaginary format normalized to 1 ohm:

```
# kHz H RI R 1
```

Frequency in Hz, G-parameters in magnitude-angle, format normalized to 1 ohm:

```
# Hz G MA R 1
```

[Reference]

Rules for Version 1.0 Files:

The [Reference] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Reference] keyword and associated data provide a per-port definition of the reference environment used for the S-parameter measurements in the network data. It may appear only once in the file.

The [Reference] section must begin with the keyword [Reference], in brackets as shown. This keyword is followed by one or more positive integer or floating-point numbers, separated from the keyword and each other by whitespace. [Reference] data may not be mixed with data for any other keyword in the file. [Reference] data may span multiple lines.

Each of the entries is a real-valued impedance (i.e., a resistance) and is assumed to be ordered per port numerically starting at 1 and ending with the value listed under [Number of Ports] (e.g., if [Number of Ports] contains the value “5”, five entries are expected under [Reference], ordered starting with port 1’s impedance and ending with port 5’s impedance. The [Reference] keyword assumes and refers to single-ended ports.

The units of the [Reference] impedances are ohms.

[Reference] may only appear after the options line and before any network data.

Note that complex and imaginary impedance values are not supported.

[Reference] is optional. If [Reference] is not present, the reference impedances for the S-parameter data are assumed to be defined by the option line. If [Reference] is present, it must contain an impedance entry for every port represented in the data (for example, a four-port data file using [Reference] must contain four [Reference] impedance entries).

The [Reference] keyword has no impact on G-, H-, Y- or Z-parameter data.

[Reference] arguments may begin on the line following the closing bracket of the keyword (in other words, after a carriage return and/or line feed character).

Example 1 (Version 2.0):

```
! 4-port S-parameter data
! Default impedance is overridden by the [Reference] line
! Data cannot be represented using 1.0 syntax.
! Note that the [Reference] keyword entries appear on a separate line
[Version] 2.0
# GHz S MA R 50
[Reference]
50 75 0.01 0.01
[Number of Ports] 4
[Number of Frequencies] 1
```

[Number of Ports]

Rules for Version 1.0 Files:

The [Number of Ports] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

Each Touchstone® Version 2.0 file must contain one and only one [Number of Ports] keyword and entry. The [Number of Ports] keyword and associated data define the number of single-ended ports represented by data in the file.

The [Number of Ports] line must begin with the keyword [Number of Ports], in brackets as shown. This keyword is followed by a single positive integer argument, separated from the keyword by whitespace.

The [Number of Ports] line is required for Version 2.0 files and must appear after the options line, before any other keywords and before any network data.

Example 2 (Version 2.0):

```
! 4-port S-parameter data
! Data valid for 1.0, if [Version] and [Number of Ports] are removed
[Version] 2.0
# GHz S MA R 50
[Number of Ports] 4
```

[Two-Port Data Order]

Rules for Version 1.0 Files:

The [Two-Port Data Order] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Two-Port Data Order] keyword is required only when the value for the [Number of Ports] keyword is 2. Otherwise, it is not permitted. When required, the [Two-Port Data Order] line must appear after the [Number of Ports] keyword and before any network data. Multiple [Two-Port Data Order] keywords in the same file are not permitted.

The [Two-Port Data Order] line must begin with the keyword [Two-Port Data Order], in brackets as shown. This keyword is followed by one of two string arguments separated from the keyword by whitespace: 12_21 or 21_12.

The [Two-Port Data Order] keyword is used to signify the column ordering convention. The Version 1.0 convention for two-port network data is N11, N21, N12, N22, where N11, N12, etc. represent pairs of data values. However, some tools and users have adopted the convention N11, N12, N21, N22 (a more natural order consistent with all the other n-port ordering conventions). The keyword makes the ordering of 2-port network data explicit and unambiguous in Version 2.0 files.

[Number of Frequencies]

Rules for Version 1.0 Files:

The [Number of Frequencies] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Number of Frequencies] keyword entry specifies the number of frequency points, and therefore blocks of network parameters, listed in the file.

The [Number of Frequencies] section must begin with the keyword [Number of Frequencies], in brackets as shown. This keyword is followed by an integer greater than 0.

The [Number of Frequencies] is required in Version 2.0 files.

[Number of Frequencies] must appear after the [Number of Ports] keyword and before any network data.

[Number of Frequencies] has no impact on noise parameters.

Example 3 (Version 2.0):

```
!1-port Z-parameter file, multiple frequency points
[Version] 2.0
# MHz Z MA
[Reference] 20.0
[Number of Ports] 1
[Number of Frequencies] 5
```

[Number of Noise Frequencies]

Rules for Version 1.0 Files:

The [Number of Noise Frequencies] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Number of Noise Frequencies] keyword entry specifies the number of noise frequency points, and therefore blocks of noise parameters, listed in the file.

The [Number of Noise Frequencies] section must begin with the keyword [Number of Noise Frequencies], in brackets as shown. This keyword is followed by an integer greater than 0.

The [Number of Noise Frequencies] is required in Version 2.0 files only if noise parameter data is provided.

[Number of Noise Frequencies] must appear after the [Version] keyword and before any network data.

Example 4 (Version 2.0):

```
!2-port network, S-parameter and noise data
!Default MA format, GHz frequencies, 50 ohm reference, S-parameters
[Version] 2.0
#
[Reference] 50 25.0
[Number of Ports] 2
[Two-Port Data Order] 21_12
[Number of Frequencies] 2
[Number of Noise Frequencies] 2
```

[Matrix Format]

Rules for Version 1.0 Files:

The [Matrix Format] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Matrix Format] keyword entry specifies whether an entire matrix or a subset of all matrix elements is given for single-ended data. The latter case is applicable to symmetric matrices for which either only the lower triangular part (including the diagonal), or only the upper triangular part (including the diagonal) can be given. This assumption is most appropriate for interconnects. Note that all ports are always represented, but the format for the data takes advantage of symmetry to reduce the overall file size.

The [Matrix Format] section must begin with the keyword [Matrix Format], in brackets as shown. This keyword is followed by one of three possible strings: “Full”, “Lower” or “Upper”.

[Matrix Format] must appear after the [Number of Ports] keyword and before any network data.

[Matrix Format] is optional. If [Matrix Format] is not present, the network data included in the file is assumed to be of type “Full” and the network data for each port as specified under [Number of Ports] must be specified for each frequency point.

[Matrix Format] has no effect on noise data.

Example 5 (Version 2.0):

```
! 4-port S-parameter data
! Default impedance is overridden by the [Reference] line
! Data cannot be represented using 1.0 syntax.
[Version] 2.0
# GHz S MA R 50
[Reference] 50 75 0.01 0.01
[Number of Ports] 4
[Number of Frequencies] 1
[Matrix Format] Full
[Network Data]
5.00000 0.60 161.24 0.40 -42.20 0.42 -66.58 0.53 -79.34 !row 1
          0.40 -42.20 0.60 161.20 0.53 -79.34 0.42 -66.58 !row 2
          0.42 -66.58 0.53 -79.34 0.60 161.24 0.40 -42.20 !row 3
          0.53 -79.34 0.42 -66.58 0.40 -42.20 0.60 161.24 !row 4
```

Example 6 (Version 2.0):

```
! 4-port S-parameter data
! Default impedance is overridden by the [Reference] line
! Data cannot be represented using 1.0 syntax.
[Version] 2.0
# GHz S MA R 50
[Reference] 50 75 0.01 0.01
[Number of Ports] 4
[Number of Frequencies] 1
[Matrix Format] Lower
[Network Data]
5.00000 0.60 161.24                                     !row 1
          0.40 -42.20 0.60 161.20                       !row 2
          0.42 -66.58 0.53 -79.34 0.60 161.24         !row 3
          0.53 -79.34 0.42 -66.58 0.40 -42.20 0.60 161.24 !row 4
```

[Network Data]

Rules for Version 1.0 Files:

The [Network Data] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Network Data] keyword explicitly identifies the beginning of the network data in a Touchstone 2.0 file. Each Touchstone® Version 2.0 file must contain one and only one [Network Data] keyword and entry.

The [Network Data] line is required for Version 2.0 files and must appear after the [Number of Ports] keyword and immediately before any network data.

Example 7 (Version 2.0):

```

!1-port Z-parameter file, multiple frequency points
[Version] 2.0
# MHz Z MA
[Reference] 20.0
[Number of Ports] 1
[Number of Frequencies] 5
[Network Data]
!freq magZ11 angZ11
100 74.25 -4
200 60 -22
300 53.025 -45
400 30 -62
500 0.75 -89

```

Single-Ended Network Parameter Data

Following the option line (Version 1.0 files) and/or [Network Data] keyword (Version 2.0 files) are the network parameters (S-parameter, Z-parameter, etc.) of the type specified by the option line. Groups of n-port parameters are preceded by the frequency value for which the data was obtained, and the n-port parameters themselves are formatted as pairs of values (magnitude-angle, dB-angle or real-imaginary).

Network data is grouped into one or more ‘lines’ which end with a terminating newline character (e.g., CR or CR/LF). In Version 1.0 files, for each frequency, n-port parameters for 1-port and 2-port networks are contained on one data line, while data for 3-port and larger networks are arranged on multiple data lines in a matrix row-wise order.

In summary, there are five general rules for formatting network data into lines:

1. In Version 1.0 files, no more than four pairs of n-port parameters are allowed per data line. No restriction exists on the number of data pairs on a line in Version 2.0 files.
2. Individual entries in data lines are separated by whitespace.
3. A data line is terminated by a newline character (CR or CR/LF combination).
4. All data lines must be arranged in increasing order of frequency.
5. Frequency values may only appear at the beginning of lines, after the newline character.

Detailed descriptions for arranging the data for various n-port networks follow.

Note that H- and G- parameters are defined for 2-port networks only. These hybrid parameters cannot be used to describe networks containing any other number of ports.

Rules for Version 2.0:

In Version 2.0 files, the data associated with any one frequency may be split across any number of lines or may be placed on a single line of arbitrary length. Data in a Version 2.0 file is parsed using the [Number of Ports] entry and the [Matrix Format] entry. For a Full matrix, a new frequency point is expected every $2n^2+1$ values, where n is the number of ports, regardless of intervening newline characters. For a Lower or Upper matrix, a new frequency point is expected every n^2+n+1 values

Note that data may be represented in mixed-mode format when the [Mixed-Mode Order] keyword is present. Note that the traditional (conventional) single-ended data used in Touchstone 1.0 and the mixed-mode representation are mutually exclusive; the same file cannot contain both as separate sets of data, since the [Mixed-Mode Order] keyword and associated data can include single-ended network parameters.

1-port and 2-port Networks

Network parameter data for 1-port and 2-port networks at a single frequency can be contained on a single data line. As shown below, the data line consists of a frequency value followed by either one or four pairs of data values.

1-port data (line)

```
<frequency value> <N11>
```

2-port data (line)

```
<frequency value> <N11> <N21> <N12> <N22>
```

where

frequency value frequency at which the network parameter data was taken or derived.

N11, N21, N12, N22 network parameter data points, where *Nij* represents a pair of data values.

Note that Version 2.0 files containing 2-port network data require the [Two-Port Data Order] keyword with the argument 21_12 to designate the order above. Use of the [Two-Port Data Order] keyword with the argument 12_21 permits the alternate order, shown below, to be used.

2-port data (line)

```
<frequency value> <N11> <N12> <N21> <N22>
```

where

frequency value frequency at which the network parameter data was taken or derived.

N11, N12, N21, N22 network parameter data points, where *Nij* represents a pair of data values.

Network parameter data points will be in magnitude-angle, dB-angle or real-imaginary format (i.e., pairs of values) as specified by the option line. For 1-port networks, only '11' data is allowed for Full, Upper or Lower format.

For Full 2-port networks, all four port data pairs are required. If [Matrix Format] is specified as Lower or Upper, 2-port network data includes only '11', '21' and '22' data, in that order (as '21' and '12' are assumed identical, Lower and Upper 2-port network data matrices are identical).

All entries in a data line are separated by one or more whitespace characters; a data line itself is terminated by a newline character (CR or CR/LF). Multiple data lines are allowed but, as mentioned above, they must be arranged in increasing order of frequency.

Shown below are some examples of Touchstone® files for 1-port and 2-port networks. Lines beginning with a bang (!) symbol are comments.

Example 8 (Version 1.0):

```
!1-port S-parameter file, single frequency point
# MHz S MA R 50
!freq magS11 angS11
2.000 0.894 -12.136
```

In the above example, the value of S11 at a frequency of 2 MHz is given in magnitude-angle format. The reference impedance is 50 ohms.

Example 9 (Version 1.0):

```
!1-port Z-parameter file, multiple frequency points
```

```
# MHz Z MA R 75
!freq magZ11 angZ11
100 0.99 -4
200 0.80 -22
300 0.707 -45
400 0.40 -62
500 0.01 -89
```

Note that, in the above example, Z11 is normalized to 75 ohms, as given by the reference impedance (R 75) in the option line.

Example 10 (Version 2.0):

```
!1-port Z-parameter file, multiple frequency points
[Version] 2.0
# MHz Z MA
[Reference] 20.0
[Number of Ports] 1
[Number of Frequencies] 5

In the above example, the S-parameter data is given in real-imaginary format, with a 50 ohm reference impedance.

3-port and 4-port Networks

Rules for Version 1.0 Files:

The network parameter data for a 3-port or 4-port network is arranged in a matrix row-wise order, with each line of data representing one row of the matrix. In other words (as shown below), the data for a 3-port network is entered as three lines of data, with each line containing three data pairs (i.e. a 3x3 matrix of network parameter values). Likewise, the data for a 4-port network is entered as four lines with four data pairs per line (a 4x4 matrix). As required by the general rules, each network parameter data group is preceded by the frequency value at which the data was taken.

N11, N12, etc. network parameter data, where *Nij* represents a pair of data values.

As usual, network parameter data is entered in magnitude-angle, dB-angle or real-imaginary format (i.e. pairs of values) as specified by the option line. All entries in a data line are separated by one or more whitespace characters; a data line itself is terminated by a newline character (CR or CR/LF)..

Shown below is an example of an S-parameter description of a 4-port network.

Note that the data pairs do not have to be aligned in columns; the only requirement is that there be 3 (3-port networks) or 4 (4-port networks) pairs of n-port parameters per data line.

Rules for Version 2.0 Files:

As noted earlier and as required by the general rules, each group of network parameter data is preceded by the frequency value at which the data was taken. The rest of the data for that frequency may follow on the same line or be split across multiple lines with intervening line-termination characters. Each frequency point must begin after a line-termination character on the first column of the line.

For files using a [Matrix Format] of Lower or Upper, data is still represented in a row-wise format. “Row” here refers to the arrangement of port data into rows and columns by relationship, not in terms of actual lines of data in the Touchstone file text (e.g., S_{ij} refers to the S-parameters from port j to port i ; the data is therefore associated with row i and column j). In a Full Matrix, data for all elements in a matrix row must be shown before data for the next row can be shown.

Matrices using the Upper format will include explicit data for row 1 ports (i.e., S_{11} , S_{12} ... S_{1n}) before any data for row 2 is shown (i.e., S_{22} , S_{23} ... S_{2n}). In the Upper format, each successive row will contain one fewer element than the previous row. The element removed is the column number (current row – 1). For example, the first element of the second row of data is S_{22} . S_{21} is not shown, as it is assumed to be identical to S_{12} from symmetry. The final element in an Upper matrix will be S_{nn} , where n is the total number of ports, representing the only data for that row.

In the Lower format, each successive row will contain one more element than the previous row. The first row consists of only one element, S_{11} . The final row will contain elements for each column from 1 to n , where n is the total number of ports.

Therefore, for a three-port matrix, data would be ordered as shown below.

where

frequency value frequency at which the network parameter data was taken or derived.

N_{11} , N_{12} , etc. network parameter data, where N_{ij} represents a pair of data values.

5-port and Above Networks

The n-port parameters for 5-port and above networks are also arranged in a matrix row-wise order.

Rules for Version 1.0 Files:

Version 1.0 files are limited to a maximum of 4 network parameter data pairs per line, additional entries beyond the first four pairs in the matrix row must be continued on the following line(s). Each row of the matrix must start on a new line.

Rules for Version 2.0 Files:

Version 2.0 files may continue data on the same line, or across multiple lines. As usual, each group of network data pairs is preceded by the frequency value at which this data was taken.

For files using a [Matrix Format] of Lower or Upper, data is still represented in a row-wise format, as shown for 3- and 4-port networks above.

These rules are illustrated by showing the format for a 6-port network:

As shown, each row of matrix data extends over two lines of the file, and each new row of the matrix starts on a new line. As usual, n-port parameters values are entered in pairs according to the format specified in the option line and each entry is separated by whitespace.

Following is a more detailed example illustrating the Full data matrix for a 10-port network. The Y-parameter data is in magnitude-angle format, and is for a single frequency.

Introduction to Mixed-Mode Concepts

This section provides the basic definitions and terminology regarding mixed-mode n -port parameters.

A differential port is formed from two single-ended ports having the same "reference" terminal (also referred to as the "-" terminal). Electrical quantities associated with a differential port formed from two single-ended ports i and j are established from the single-ended port quantities V_i , I_i , V_j and I_j as

$$\text{common mode voltage} \quad V_{Ci,j} = (V_i + V_j)/2 \quad (a)$$

$$\text{common mode current} \quad I_{Ci,j} = I_i + I_j \quad (b)$$

$$\text{differential mode voltage} \quad V_{Di,j} = V_i - V_j \quad (c)$$

$$\text{differential mode current} \quad I_{Di,j} = (I_i - I_j)/2 \quad (d)$$

The notation $C_{i,j}$ and $D_{i,j}$ signifies the mode, common or differential, respectively, as well as the indices and the order of the single-ended ports from which the differential port is formed.

For mixed-mode S parameters, the relationships between the mixed-mode incident and reflected waves and the aforementioned mixed-mode voltages and currents are similar to those for the conventional quantities, specifically

$$\text{common mode incident wave} \quad a_{Ci,j} = (V_{Ci,j} + R_{Ci,j} \times I_{Ci,j}) / (2 \times \sqrt{R_{Ci,j}}) \quad (e)$$

$$\text{common mode reflected wave} \quad b_{Ci,j} = (V_{Ci,j} - R_{Ci,j} \times I_{Ci,j}) / (2 \times \sqrt{R_{Ci,j}}) \quad (f)$$

$$\text{differential mode incident wave} \quad a_{Di,j} = (V_{Di,j} + R_{Di,j} \times I_{Di,j}) / (2 \times \sqrt{R_{Di,j}}) \quad (g)$$

$$\text{differential mode reflected wave} \quad b_{Di,j} = (V_{Di,j} - R_{Di,j} \times I_{Di,j}) / (2 \times \sqrt{R_{Di,j}}) \quad (h)$$

In general, and as is the case for the conventional S parameters, the mixed-mode reference impedances $R_{Ci,j}$ and $R_{Di,j}$ could be selected as any positive real numbers. However, this is further limited in Version 2.0 files, as explained below. Furthermore, complex reference impedances are not supported.

The relationships between the conventional and mixed-mode incident and reflected waves depend on the actual values of the reference impedances $R_{Ci,j}$ and $R_{Di,j}$ relative to the reference impedances R_i and R_j for the conventional incident and reflected waves for the two single-ended ports i and j forming the differential port. One common selection for this relationship is such that R_i and R_j are equal, $R_{Ci,j}$ is half that value and $R_{Di,j}$ is twice that value.

Specifically, if

$$\text{Condition 1:} \quad R_i = R_j = R$$

and

$$\text{Condition 2:} \quad R_{Ci,j} = R/2 \quad \text{and} \quad R_{Di,j} = 2R$$

then

$$a_{Ci,j} = (a_i + a_j) / \sqrt{2} \quad (i)$$

$$a_{Di,j} = (a_i - a_j) / \sqrt{2} \quad (j)$$

$$b_{Ci,j} = (b_i + b_j) / \sqrt{2} \quad (k)$$

$$b_{Di,j} = (b_i - b_j) / \sqrt{2} \quad (l)$$

Version 2.0 files do not provide the means to specify directly the mixed mode reference impedances $R_{Ci,j}$ and $R_{Di,j}$. Instead the single-ended port reference impedances R_i and R_j are specified by means of the [Reference] keyword, or by the Option line. Thus, the mixed-mode reference impedances need to be unambiguously defined from the [Reference] data, and therefore **Condition 1** and **Condition 2** above are adopted for Version 2.0 files. Note that under these conditions the relationships (i)-(l) do not depend on the actual values of the reference impedances, and take a very simple form.

The value R in **Condition 1** and **Condition 2** can be different for different pairs i,j of the single-ended ports forming different differential ports.

Similarly to the conventional n -port parameters the term mixed-mode n -port parameters refers to any one of the $n \times n$ matrices S , Y , or Z linking the voltages, currents or the wave quantities as

$$V = Z I \quad I = Y V \quad b = S a$$

The difference is that for the mixed-mode n -port parameters the vectors V , I , b and a , are defined using the aforementioned common and differential mode quantities while the single-ended port quantities are used in the conventional relationships. The mixed mode n -port parameters can be the generalized mixed-mode parameters when not all single-ended ports are combined into differential ports. For those ports that remain single-ended, the single-ended quantities appear in the vectors V , I , b and a .

All the single-ended ports of any n -port circuit characterized by the Touchstone® files are assumed to be ordered with consecutive numbers from 1 to n . This is the “reference port order” which also determines the matrix entries in the conventional S , Y or Z matrices. Specifically, the k^{th} elements in the vectors V , I , b and a in the conventional relationships are those of the k^{th} single-ended port.

Version 2.0 files do not impose any specific order of the mixed-mode quantities in the vectors V , I , b and a in the mixed-mode relationships. Instead the keyword [Mixed-Mode Order] provides the means to specify how these quantities are ordered with respect to the reference port order. The only requirement is that the same order (specified by [Mixed-Mode Order]) applies to all the vectors V , I , b and a .

Appendix A provides the formulas for the relationships between the conventional and mixed-mode n -port parameter for the case when the **Condition 1** and **Condition 2** are satisfied.

[Mixed-Mode Order]

Rules for Version 1.0 Files:

The [Mixed-Mode Order] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Mixed-Mode Order] keyword entry specifies a list or vector of ports and port descriptors described with mixed-mode network data elsewhere in the file. The [Mixed-Mode Order] list determines the content and the row/column arrangement used for the network data.

The [Mixed-Mode Order] keyword is only required if mixed-mode data is present elsewhere in the file.

Port numbers used under [Mixed-Mode Order] are single-ended. No definition or syntax is used to define mixed-mode ports, only mixed-mode relationships between single-ended ports.

Every single-ended port (the number described under [Number of Ports]) must be mentioned in a descriptor under [Mixed-Mode Order].

[Mixed-Mode Order] uses one of the following characters combinations to represent descriptors:

$S<port>$
 $C<port>, <port>$
 $D<port>, <port>$

where

C, D, S specifies whether the descriptor is common-mode, differential-mode or single-ended. Legal values are S (for single-ended), C (for common-mode) and D (for differential-mode). If the letter S is present and followed by a single integer, a single-ended descriptor is being defined. A letter may not appear by itself, nor may an integer appear by itself. When a pair of ports is present, the second port listed is assumed to be the reference port.

$port$ an integer, specifies the number of the single-ended port(s) described in the descriptor. The integer number corresponds to the order of the ports as described under the [Reference] keyword. Only non-zero integers may be used. For single-ended descriptor groups, a single integer is used. For mixed-mode data, two port integers are used, separated by a single comma without whitespace, carriage returns, or line feeds. Multiple commas without separation by integers are not permitted.

Descriptor groups are separated by whitespace, including carriage returns and/or line feeds.

Note that any one port number may only appear in one single-ended or two mixed-mode descriptors. Additionally, any common-mode descriptor present between ports necessitates that a differential-mode descriptor be present between the same ports, and vice-versa. For example, if D1,3 is included under [Mixed-Mode Order], C1,3 must also be included. S3 would be prohibited. C2,3 would also be prohibited.

The number of ports described under the [Number of Ports] keyword must match the number of descriptors described under [Mixed-Mode Order]. Similarly, the numeric value described under [Number of Ports] must match the highest integer port number listed in any descriptor under [Mixed-Mode Order].

[Mixed-Mode Order], if used, must appear after the [Number of Ports] keyword and before any network data.

[Mixed-Mode Order] arguments may begin on the line following the closing bracket of the keyword (in other words, after a carriage return and/or line feed character).

Mixed-Mode Network Parameter Data

Rules for Version 1.0 Files:

Mixed-mode data is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

Mixed-mode data consists of matrices using the relationships and order described under the [Mixed-Mode Order] keyword.

Only S-, Y- or Z-parameter data may be represented using the mixed-mode format.

Note that the port numbering does not necessarily determine the arrangement of data under mixed-mode data. Only the [Mixed-Mode Order] keyword determines how mixed-mode data is arranged. Only relationships and ports specified under [Mixed-Mode Order] may appear as part of mixed-mode data.

Reference impedances for mixed-mode data are assumed single-ended, as presented under the [Reference Impedance] keyword. For common-mode and differential-mode relationships, the same value of reference impedance must be used under [Reference Impedance] for both ports. Differential-mode relationships assume an impedance across the ports of twice the single-ended value specified for either port in the relationship. Common-mode relationships assume an impedance across the ports of half the single-ended value specified for either port in the relationship..

The rules for presenting frequency, line breaks and other aspects of formatting follow those for traditional single-ended network data.

[Matrix Format] may be used with mixed-mode data, so long as the data follows the keyword's symmetry requirements.

The mixed-mode matrix arrangement assumes that the vector in [Mixed-Mode Order] describes the diagonal of the mixed-mode matrix. In other words, the i -th value of the vector is used for both the stimulus and response used for the resulting matrix value N_{ii} . The matrix value N_{ij} would result from vector value i as the response value in row i and the vector value j as the stimulus value in column j . This follows the stimulus-response convention used both widely in the industry for proprietary mixed-mode data formats, as well as the traditional Touchstone 1.0 single-ended data format.

For example, for a 3-port network, the [Mixed-Mode Order] keyword may contain the values:

D1,2 S3 C1,2

This specifies a differential relationship for ports 1 and 2, followed by a single-ended data relationship for port 3 and a common-mode relationship for ports 1 and 2. The mixed-mode data matrix would therefore use the following format:

[Noise Data]

Rules for Version 1.0 Files:

The [Noise Data] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Noise Data] keyword identifies the block of noise parameter data, if present in the file. Each Touchstone® Version 2.0 file must contain one and only one [Noise Data] keyword and entry, if and only if [Number of Noise Frequencies] is defined.

[Noise Data] shall only appear after the [Network Data] keyword and entries.

Noise Parameters

Noise parameters may be included in Touchstone® data files. However, they may only be included in files describing 2-port networks. Noise parameters follow the G-, H-, S-, Y-, or Z-parameter data (Version 1.0 files) and the [Noise Data] keyword (Version 2.0 files) for all frequency points. Note that the rules for noise parameters are significantly different than the rules for the S-parameter, Z-parameter, etc. data elsewhere in Touchstone® files.

Each line of noise parameters has the following five entries:

<x1> <x2> <x3> <x4> <x5>

where

- x1* Frequency, in the units specified on the option line, or GHz, if no units are specified. The first group of noise data must have a frequency less than or equal to the highest frequency used for the S-parameter, Z-parameter, etc. data earlier in the file.
- x2* Minimum noise figure in dB.
- x3* Source reflection coefficient to realize minimum noise figure. This is a magnitude, regardless of the format specified on the option line. The values used for *x3* and *x4* form a complex pair, taken with reference to the impedance value specified on the option line. If no impedance is listed on the option line, the assumed reference is 50 ohms.
- x4* Phase of the reflection coefficient, in degrees. As noted above, this is taken with respect to the reference specified on the option line or, if no impedance is listed, an assumed value of 50 ohms.
- x5* Effective noise resistance. A simulator requires this parameter to meet physical requirements. If the user-supplied *x5* value is less than allowed for this requirement, then a simulator may force this *x5* value to the lowest physical limit. For Version 1.0 files, this is normalized to the impedance specified on the option line, or 50 ohms if no value is given specified. No normalization is assumed for Version 2.0 files.

Note that the frequencies for noise parameters and network parameters need not match. The only requirement is that the first noise parameter frequency be less than or equal to the highest network parameter frequency. For Version 1.0 files, this allows the file processor to determine where the network parameters end and the noise parameters begin. For Version 2.0 files, the [Number of Frequencies] keyword specifies, the size of the network parameter data expected before any noise parameters begin. As with network parameter data, all noise parameter data must be arranged in increasing order of frequency

The [Number of Noise Frequencies] keyword is required if any noise parameters are present in the file. The [Number of Noise Frequencies] keyword is prohibited if no noise parameters are present in the file.

The [Reference] keyword has no effect on noise parameter data.

If noise parameters are present in the file, the [Number of Ports] keyword must have “2” as its argument.

In both Version 1.0 and Version 2.0, each noise parameter frequency and associated data must be grouped into a single line, terminated with a newline character.

Rules for Version 1.0 Files:

The [End] keyword is not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [End] keyword defines the end of the Touchstone 2.0. Non-comment text appearing after the [End] keyword should be treated as an error.

INFORMATION DESCRIPTION

Introduction

This section is reserved for future expansion with new informational keywords for specific applications. While this information could be documented by comment lines, the keywords in this section will allow descriptions to be standardized and to be electronically parsed. These keywords are optional and can be ignored or be overridden by external references to the Touchstone 2.0 file.

[Begin Information], [End Information]

Rules for Version 1.0 Files:

The [Begin Information] and [End Information] keywords are not permitted in Version 1.0 files.

Rules for Version 2.0 Files:

The [Begin Information] keyword and associated data define information about the derivation and usage of Touchstone data for specific applications. The [Begin Information] and [End Information] keywords are optional for Version 2.0 files. If used, the keywords must only appear after the [Number of Ports] keyword and before any network data. Each Touchstone® Version 2.0 file may contain one and only one [Begin Information] keyword. Each Touchstone® Version 2.0 file that contains a [Begin Information] keyword must also contain one [End Information] keyword. The [End Information] keyword must follow the [Begin Information] keyword, and must occur before any network data.

The data between the [Begin Information] and [End Information] keywords will consist of information sections. Each information section will begin with an information keyword as defined below. The data associated with each information keyword may be on the same line as the information keyword or on subsequent lines prior to the next keyword. Each keyword or keyword-plus-data within [Begin Information] and [End Information] terminates either with another keyword or with the [End Information] keyword. Therefore, information keywords can have data or arguments that apply to fewer than the number of ports in the file documented by the [Number of Ports] keyword.

Information Keywords

This section is reserved for future expansion.

COMPATIBILITY NOTES

In the original proprietary Touchstone® specification, several restrictions existed that may not apply across implementations and do not apply to Version 1.0 or 2.0 files:

The dB/angle form was not allowed for G-, H-, Y- and Z-parameters. Only magnitude/angle and real/imaginary pairs were permitted for non-S-parameter data.

Y- and Z-parameters were not allowed for 3-port networks or larger.

The total number of ports that could be represented in any Touchstone® file was 99.

Version 1.0 and Version 2.0 files differ in three additional respects:

G-, H-, Y- and Z- parameters are normalized in Version 1.0 but are not normalized in Version 2.0.

Effective noise resistance in noise parameter data is considered normalized in Version 1.0 but is not normalized in Version 2.0.

Mixed-mode support is added in Version 2.0, so that network parameter data in the file is interpreted differently in the presence of the [Mixed-Mode Order] keyword.

APPENDIX A: Transformations between Conventional and Mixed-Mode Matrices for a Pair of Ports

We assume that the pair of single ended ports has common reference and is normalized to the same impedance value r_0 . In its mixed-mode representation, the reference impedance for the differential and common mode components is assumed to be $2r_0$ and $\frac{1}{2}r_0$ respectively.

We'll give relationships between the vectors and matrices for a port pair, participating in standard-to-mixed-mode transformation.

For convenience, we will use the two matrices:

$$\mathbf{M} = \begin{bmatrix} \gamma & -\gamma \\ \gamma & \gamma \end{bmatrix} \text{ and } \mathbf{K} = \begin{bmatrix} 1/\gamma & 0 \\ 0 & \gamma \end{bmatrix}, \text{ where } \gamma = \frac{1}{\sqrt{2}}.$$

The inverse of the matrix \mathbf{M} is also its transpose: $\mathbf{M}^{-1} = \mathbf{M}^t$.

S-parameters

The incident and reflected waves in standard and mixed-mode are related as follows:

$$\mathbf{a}_{\text{mm}} = \begin{bmatrix} a_{D1,2} \\ a_{C1,2} \end{bmatrix} = \mathbf{M} \begin{bmatrix} a_1 \\ a_2 \end{bmatrix} = \mathbf{M} \mathbf{a}_{\text{std}} \quad (\text{S1})$$

$$\mathbf{b}_{\text{mm}} = \begin{bmatrix} b_{D1,2} \\ b_{C1,2} \end{bmatrix} = \mathbf{M} \begin{bmatrix} b_1 \\ b_2 \end{bmatrix} = \mathbf{M} \mathbf{b}_{\text{std}} \quad (\text{S2})$$

$$\mathbf{b}_{\text{std}} = \mathbf{S}_{\text{std}} \mathbf{a}_{\text{std}} \quad (\text{S3})$$

$$\mathbf{b}_{\text{mm}} = \mathbf{S}_{\text{mm}} \mathbf{a}_{\text{mm}} \quad (\text{S4})$$

By substituting (S1), (S2) into (S4), it is possible to find the relations between the mixed-mode and standard mode S-matrices:

$$\mathbf{S}_{\text{std}} = \mathbf{M}^t \mathbf{S}_{\text{mm}} \mathbf{M} \quad (\text{S5})$$

$$\mathbf{S}_{\text{mm}} = \mathbf{M} \mathbf{S}_{\text{std}} \mathbf{M}^t \quad (\text{S6})$$

Y and Z-parameters

First, we express mixed-mode voltages and currents (vectors) via standard mode vectors.

$$\mathbf{V}_{\text{mm}} = \begin{bmatrix} v_{D1,2} \\ v_{C1,2} \end{bmatrix} = \begin{bmatrix} 1 & -1 \\ 0.5 & 0.5 \end{bmatrix} \begin{bmatrix} v_1 \\ v_2 \end{bmatrix} = \begin{bmatrix} 1/\gamma & 0 \\ 0 & \gamma \end{bmatrix} \begin{bmatrix} \gamma & -\gamma \\ \gamma & \gamma \end{bmatrix} \begin{bmatrix} v_1 \\ v_2 \end{bmatrix} = \mathbf{K} \mathbf{M} \mathbf{V}_{\text{std}} \quad (\text{YZ1})$$

$$\mathbf{I}_{\text{mm}} = \begin{bmatrix} i_{D1,2} \\ i_{C1,2} \end{bmatrix} = \begin{bmatrix} 0.5 & -0.5 \\ 1 & 1 \end{bmatrix} \begin{bmatrix} i_1 \\ i_2 \end{bmatrix} = \begin{bmatrix} \gamma & 0 \\ 0 & 1/\gamma \end{bmatrix} \begin{bmatrix} \gamma & -\gamma \\ \gamma & \gamma \end{bmatrix} \begin{bmatrix} i_1 \\ i_2 \end{bmatrix} = \mathbf{K}^{-1}\mathbf{M}\mathbf{I}_{\text{std}} \quad (\text{YZ2})$$

Then, define relationships between voltages and currents, in standard and mixed-mode.

$$\mathbf{I}_{\text{std}} = \mathbf{Y}_{\text{std}} \mathbf{V}_{\text{std}} \quad (\text{YZ3})$$

$$\mathbf{V}_{\text{std}} = \mathbf{Z}_{\text{std}} \mathbf{I}_{\text{std}} \quad (\text{YZ4})$$

$$\mathbf{I}_{\text{mm}} = \mathbf{Y}_{\text{mm}} \mathbf{V}_{\text{mm}} \quad (\text{YZ5})$$

$$\mathbf{V}_{\text{mm}} = \mathbf{Z}_{\text{mm}} \mathbf{I}_{\text{mm}} \quad (\text{YZ6})$$

By substituting (YZ1), (YZ2) into (YZ3-6) we can find relationships between the standard and mixed-mode \mathbf{Y} and \mathbf{Z} -matrices:

$$\mathbf{Y}_{\text{mm}} = (\mathbf{K}^{-1}\mathbf{M})\mathbf{Y}_{\text{std}}(\mathbf{K}^{-1}\mathbf{M})^t \quad (\text{YZ7})$$

$$\mathbf{Y}_{\text{std}} = (\mathbf{KM})^t \mathbf{Y}_{\text{mm}} (\mathbf{KM}) \quad (\text{YZ8})$$

$$\mathbf{Z}_{\text{mm}} = (\mathbf{KM})\mathbf{Z}_{\text{std}}(\mathbf{KM})^t \quad (\text{YZ9})$$

$$\mathbf{Z}_{\text{std}} = (\mathbf{K}^{-1}\mathbf{M})^t \mathbf{Z}_{\text{mm}} (\mathbf{K}^{-1}\mathbf{M}) \quad (\text{YZ10})$$

Mutual Transformations in Cases of Several Port Pairs

All above relationships apply only to individual port pairs participating in MM to STD transformations. In case of many such pairs, and also in presence of single ended components together with mixed-mode, we need more general description. The transformation matrix in this case will consist of several 2x2 diagonal blocks - each one for every mixed-mode port pair - and a unit matrix diagonal block that corresponds to single ended ports.

For example, the combined mixed-mode vector $\mathbf{X}_{\text{mm_blk}}$ and single ended component vector \mathbf{X}_{std} could be related as:

$$\mathbf{X}_{\text{mm_blk}} = \begin{bmatrix} X_{D1,2} \\ X_{C1,2} \\ X_{D3,4} \\ X_{C3,4} \\ X_5 \end{bmatrix} = \begin{bmatrix} \mathbf{T}_{X2} & \mathbf{0} & \mathbf{0} \\ \mathbf{0} & \mathbf{T}_{X2} & \mathbf{0} \\ \mathbf{0} & \mathbf{0} & \mathbf{E}_1 \end{bmatrix} \begin{bmatrix} X_1 \\ X_2 \\ X_3 \\ X_4 \\ X_5 \end{bmatrix} = \mathbf{T}_X \mathbf{X}_{\text{std_blk}} \quad (\text{P1})$$

Here, \mathbf{T}_{X2} is an elementary 2x2 transformation matrix block. Depending on the type of variables in X (incident or reflected wave, voltage or current), it is:

$$\mathbf{T}_{A2} = \mathbf{T}_{B2} = \mathbf{M} \quad (\text{for incident and reflected wave}) \quad (\text{P2})$$

$$\mathbf{T}_{V2} = \mathbf{KM} \quad (\text{for port voltage vector}) \quad (\text{P3})$$

$$\mathbf{T}_{I2} = \mathbf{K}^{-1}\mathbf{M} \quad (\text{for port current vector}) \quad (\text{P4})$$

\mathbf{E}_1 is 1x1 identity matrix. The size of it is defined by the number of individual single ended ports in the left side ‘extended’ mixed-model vector. The matrix components designated by zeros are square or rectangular all-zero block matrices. Their size is determined by the size of the corresponding diagonal blocks.

Note that (P1) only describes the case when variables on the left and right are ‘properly’ ordered. The proposed standard allows arbitrary ordering of components in the mixed-mode vector. In addition to the block-wise transformation, as shown in (P1), we may consider a chain of several transformations, including permutations and MM/STD transformations:

$$\mathbf{X}_{\text{mm}} \Leftarrow \text{perm_mm} \Rightarrow \mathbf{X}_{\text{mm_blk}} \Leftarrow \text{MM_to_STD} \Rightarrow \mathbf{X}_{\text{std_blk}} \Leftarrow \text{perm_std} \Rightarrow \mathbf{X}_{\text{std}}$$

For example, possible transformations are:

$$\begin{bmatrix} X_{D3,2} \\ X_{D5,4} \\ X_1 \\ X_{C3,2} \\ X_{C5,4} \end{bmatrix} \Leftrightarrow \begin{bmatrix} X_{D3,2} \\ X_{C3,2} \\ X_{D5,4} \\ X_{C5,4} \\ X_1 \end{bmatrix} \Leftrightarrow \begin{bmatrix} X_3 \\ X_2 \\ X_5 \\ X_4 \\ X_1 \end{bmatrix} \Leftrightarrow \begin{bmatrix} X_1 \\ X_2 \\ X_3 \\ X_4 \\ X_5 \end{bmatrix}. \quad (\text{P5})$$

Given a vector \mathbf{X}_{mm} (on the left) with components ordered as defined in [Mixed-Mode Order], we need first to permute those components so as to group the mixed-mode pairs and block of single ended components (see $\mathbf{X}_{\text{mm_blk}}$, next vector). Then, we represent the vector $\mathbf{X}_{\text{mm_blk}}$ as a result of STD-to-MM transformation by way of (P1) applied to respectively grouped vector $\mathbf{X}_{\text{std_blk}}$. Finally, we permute single ended vector so as to get the components in \mathbf{X}_{std} properly ordered.

Note that two permutations (with mixed-mode and standard mode components) are independent and therefore require two permutation matrices, \mathbf{P}_{std} and \mathbf{P}_{mm} respectively. The chain of transformations in (P5), if seen from right to left becomes:

$$\mathbf{X}_{\text{std_blk}} = \mathbf{P}_{\text{std}} \mathbf{X}_{\text{std}} \quad (\text{P6})$$

$$\mathbf{X}_{\text{mm_blk}} = \mathbf{T}_X \mathbf{X}_{\text{std_blk}} \quad (\text{P7})$$

$$\mathbf{X}_{\text{mm}} = \mathbf{P}_{\text{mm}} \mathbf{X}_{\text{mm_blk}} \quad (\text{P8})$$

For example, the matrices used in (P5) are:

$$\mathbf{P}_{\text{std}} = \begin{bmatrix} 0 & 0 & 1 & 0 & 0 \\ 0 & 1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 \\ 0 & 0 & 0 & 1 & 0 \\ 1 & 0 & 0 & 0 & 0 \end{bmatrix}, \quad \mathbf{T}_X = \begin{bmatrix} \mathbf{T}_{X2} & \mathbf{0} & \mathbf{0} \\ \mathbf{0} & \mathbf{T}_{X2} & \mathbf{0} \\ \mathbf{0} & \mathbf{0} & \mathbf{E}_1 \end{bmatrix}, \quad \mathbf{P}_{\text{mm}} = \begin{bmatrix} 1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 1 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 \\ 0 & 1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 1 & 0 \end{bmatrix}.$$

From (P6-P8) we have:

$$\mathbf{X}_{mm} = (\mathbf{P}_{mm} \mathbf{T}_X \mathbf{P}_{std}) \mathbf{X}_{std} \quad (\text{P9})$$

$$\mathbf{X}_{std} = (\mathbf{P}_{std}^t \mathbf{T}_X^{-1} \mathbf{P}_{mm}^t) \mathbf{X}_{mm} . \quad (\text{P10})$$

For each type of matrix (**S**, **Y** or **Z**) we have a certain type of input and output vectors. Let us assume that **X** is an input vector (**a**, **V** or **I** respectively) and **U** is an output vector (respectively, **b**, **I** or **V**). Then, similar to (P9) and (P10) there exist relationships for the output vector:

$$\mathbf{U}_{mm} = (\mathbf{P}_{mm} \mathbf{T}_U \mathbf{P}_{std}) \mathbf{U}_{std} \quad (\text{P11})$$

$$\mathbf{U}_{std} = (\mathbf{P}_{std}^t \mathbf{T}_U^{-1} \mathbf{P}_{mm}^t) \mathbf{U}_{mm} . \quad (\text{P12})$$

Note, that permutation matrices are the same (since the components in the input/output vectors must be identically ordered) but the block-wise transformation matrix could be different. As follows from (P3), (P4), in case of **Y** or **Z**-parameters, we need to use different elementary transformation blocks for voltage and current vectors. However, in all cases the transformation matrices used in (P9-P12) obey the relations:

$$\mathbf{T}_U^t = \mathbf{T}_X^{-1} \quad (\text{P13})$$

$$\mathbf{T}_X^t = \mathbf{T}_U^{-1} \quad (\text{P14})$$

In addition to general type input and output vectors (general for **S/Y/Z** cases), we may define a general transformation matrices, \mathbf{F}_{std} and \mathbf{F}_{mm} (where **F** stands for **S**, **Y** or **Z**):

$$\mathbf{U}_{std} = \mathbf{F}_{std} \mathbf{X}_{std} \quad (\text{P15})$$

$$\mathbf{U}_{mm} = \mathbf{F}_{mm} \mathbf{X}_{mm} . \quad (\text{P16})$$

By substituting (P9), (P11) into (P16), we find:

$$\mathbf{F}_{std} = (\mathbf{P}_{std}^t \mathbf{T}_U^{-1} \mathbf{P}_{mm}^t) \mathbf{F}_{mm} (\mathbf{P}_{mm} \mathbf{T}_X \mathbf{P}_{std}) \quad (\text{P17})$$

$$\mathbf{F}_{mm} = (\mathbf{P}_{mm} \mathbf{T}_U \mathbf{P}_{std}) \mathbf{F}_{std} (\mathbf{P}_{std}^t \mathbf{T}_X^{-1} \mathbf{P}_{mm}^t) . \quad (\text{P18})$$

(P17) shows how the mixed-mode matrix, arbitrarily ordered, possibly with single ended terms, can be converted directly into properly ordered single ended form. (P18) shows the reverse transformation.

Note that because of (P13), (P14) the side matrices in (P17), (P18) enclosed in parenthesis are mutually transpose $\mathbf{P}_{std}^t \mathbf{T}_U^{-1} \mathbf{P}_{mm}^t = (\mathbf{P}_{mm} \mathbf{T}_X \mathbf{P}_{std})^t$, $\mathbf{P}_{mm} \mathbf{T}_U \mathbf{P}_{std} = (\mathbf{P}_{std}^t \mathbf{T}_X^{-1} \mathbf{P}_{mm}^t)^t$. The property is related to the fact that transformations (P17) and (P18) must preserve matrix symmetry. For example, if the standard mode matrix is symmetric, so should be the mixed-mode matrix, regardless of the permutations and the parameter type.

Example A-1:

If the vectors shown in (P5) correspond to incident and reflected waves, and the matrix type is '**S**' then the elementary transformation blocks are those of (P2), and therefore:

$$\mathbf{T}_x = \begin{bmatrix} \gamma & -\gamma & 0 & 0 & 0 \\ \gamma & \gamma & 0 & 0 & 0 \\ 0 & 0 & \gamma & -\gamma & 0 \\ 0 & 0 & \gamma & \gamma & 0 \\ 0 & 0 & 0 & 0 & 1 \end{bmatrix}.$$

Combining this matrix with permutation matrices shown above, we reduce (P15) into:

$$\mathbf{S}_{\text{std}} = \begin{bmatrix} 0 & 0 & 1 & 0 & 0 \\ -\gamma & 0 & 0 & \gamma & 0 \\ \gamma & 0 & 0 & \gamma & 0 \\ 0 & -\gamma & 0 & 0 & \gamma \\ 0 & \gamma & 0 & 0 & \gamma \end{bmatrix} \mathbf{S}_{\text{mm}} = \begin{bmatrix} 0 & -\gamma & \gamma & 0 & 0 \\ 0 & 0 & 0 & -\gamma & \gamma \\ 1 & 0 & 0 & 0 & 0 \\ 0 & \gamma & \gamma & 0 & 0 \\ 0 & 0 & 0 & \gamma & \gamma \end{bmatrix}.$$

Example A-2:

Let the touchstone data type by \mathbf{Y} (admittance matrix) and mixed-mode order is defined as column $[X_{D2,3}, X_{D6,5}, X_{C2,3}, X_{C6,5}, X_4, X_1]$, and the matrix – at certain frequency – is defined as:

$$\mathbf{Y}_{\text{mm}} = \begin{bmatrix} 8+9j & 2-j & 3-2j & 1+3j & 1+0.1j & 0.2-0.2j \\ 2-j & 7+7j & 1.8-2j & -1-j & -0.5+0.5j & 0.2-0.1j \\ 3-2j & 1.8-2j & 5.8+6j & 1.2+0.8j & 0.9+0.7j & 0.3-0.5j \\ 1+3j & -1-j & 1.2+0.8j & 6.3+8j & 2-0.5j & 1.5+0.6j \\ 1+0.1j & -0.5+0.5j & 0.9+0.7j & 2-0.5j & 4.7-6j & -1+2j \\ 0.2-0.2j & 0.2-0.1j & 0.3-0.5j & 1.5+0.6j & -1+2j & 5.5-7j \end{bmatrix}$$

By inspecting mixed-mode order, we can define the mixed-mode permutation matrix \mathbf{P}_{mm} :

$$\mathbf{X}_{\text{mm}} = \mathbf{P}_{\text{mm}} \mathbf{X}_{\text{mm_blk}}, \text{ or } \begin{bmatrix} X_{D3,2} \\ X_{D6,5} \\ X_{C3,2} \\ X_{C6,5} \\ X_4 \\ X_1 \end{bmatrix} = \begin{bmatrix} 1 & 0 & 0 & 0 & 0 & 0 \\ 0 & 0 & 1 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 1 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 0 & 0 & 1 \end{bmatrix} \begin{bmatrix} X_{D3,2} \\ X_{C3,2} \\ X_{D6,5} \\ X_{C6,5} \\ X_4 \\ X_1 \end{bmatrix}.$$

Similarly, standard mode permutation can be seen from:

$$\mathbf{X}_{\text{std_blk}} = \mathbf{P}_{\text{std}} \mathbf{X}_{\text{std}}, \text{ or } \begin{bmatrix} X_3 \\ X_2 \\ X_6 \\ X_5 \\ X_4 \\ X_1 \end{bmatrix} = \begin{bmatrix} 0 & 0 & 1 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0 & 1 \\ 0 & 0 & 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 & 0 & 0 \\ 1 & 0 & 0 & 0 & 0 & 0 \end{bmatrix} \begin{bmatrix} X_1 \\ X_2 \\ X_3 \\ X_4 \\ X_5 \\ X_6 \end{bmatrix}.$$

The transformation matrices for voltage and current vectors are different:

$$\mathbf{T}_V = \text{diag}\{\mathbf{KM}, \mathbf{KM}, \mathbf{E}_2\} = \begin{bmatrix} 1 & -1 & 0 & 0 & 0 & 0 \\ 0.5 & 0.5 & 0 & 0 & 0 & 0 \\ 0 & 0 & 1 & -1 & 0 & 0 \\ 0 & 0 & 0.5 & 0.5 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 0 & 0 & 1 \end{bmatrix},$$

$$\mathbf{T}_I = \text{diag}\{\mathbf{K}^{-1}\mathbf{M}, \mathbf{K}^{-1}\mathbf{M}, \mathbf{E}_2\} = \begin{bmatrix} 0.5 & -0.5 & 0 & 0 & 0 & 0 \\ 1 & 1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0.5 & -0.5 & 0 & 0 \\ 0 & 0 & 1 & 1 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 0 & 0 & 1 \end{bmatrix}.$$

Since for Y -parameters we consider voltage as an “input” and current as “output”, in (P17) we need to substitute \mathbf{T}_X with \mathbf{T}_V and \mathbf{T}_U with \mathbf{T}_I . Then, (P17) simplifies to

$$\mathbf{Y}_{\text{std}} = \begin{bmatrix} 0 & 0.5 & 1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0.5 & 1 \\ 0 & 0.5 & -1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0.5 & -1 \\ 0 & 0 & 0 & 1 & 0 & 0 \\ 1 & 0 & 0 & 0 & 0 & 0 \end{bmatrix} \mathbf{Y}_{\text{mm}} \begin{bmatrix} 0 & 0 & 0 & 0 & 0 & 1 \\ 0.5 & 0 & 0.5 & 0 & 0 & 0 \\ 1 & 0 & -1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 & 0 \\ 0 & 0.5 & 0 & 0.5 & 0 & 0 \\ 0 & 1 & 0 & -1 & 0 & 0 \end{bmatrix}$$

Finally, with given complex \mathbf{Y}_{mm} we get:

$$\mathbf{Y}_{\text{std}} = \begin{bmatrix} 9.35+5.75j & 0.725-0.075j & -4.05-4.25j & -0.075+1.025j & 0.7+0.3j & 4-2.5j \\ 0.725-0.075j & 5.675-6.5j & -0.775+0.225j & -4.325+5.5j & 2.5+0.35j & 0.7-0.15j \\ -4.05-4.25j & -0.775+0.225j & 5.75+9.75j & -0.375-0.675j & -1.7-1.3j & -2+1.5j \\ -0.075+1.025j & -4.325+5.5j & -0.375-0.675j & 7.675-10.5j & -0.5-0.85j & 0.3+0.25j \\ 0.7+0.3j & 2.5+0.35j & -1.7-1.3j & -0.5-0.85 & 6.3+8j & 1+3j \\ 4-2.5j & 0.7-0.15j & -2+1.5j & 0.3+0.25j & 1+3j & 8+9j \end{bmatrix}$$
